Know all men by these Presents that we Tarlton Brown Burwell Rieves & William Ryan are held and firmly bound with Thomas Hale in the sum of One Hundred pounds to be paid unto the said Thomas Hale his certain Attorney his Heirs Executors Administrators or Assigns, to which Payment well and Fairly to be made, we bind Ourselves Our Heirs Executors and Administrators Jointly & Severally firmly by these Presents sealed with our seals and Dated this 8<sup>th</sup> day of March 1796

The condition of the above obligation is such that whereas in an action of Trespass the case commenced and presented in the County Court of Franklin by the said Thomas Hale against the said Tarton (sic) Brown a Verdict and Judgment did on this day Pass for the Plf that he should recover One Hundred & thirty thre (sic) Dollars & 33 Cents and his Costs by his about his suit in that behalf expended, from which Judgment the said Tarlton Brown hath appealed to the District Court to be held at New London in Campbell County in April next. If therefor the said Tarlton Brown shall effectually present the said appeal and pay such Costs and Damages as shall be awarded by the said District Court in case the Judgment Aforesaid shall be confirmed, then the Obligation to be Void else to remain in full force
